## 4.24 PRISON LOGBOOK

This is a prosecution for conspiracy to commit three murders. The defendant, Jerry Stone, was an inmate at the Ironside Correctional Center at the time of the acts alleged in the indictment. The prosecution's theory is that the actual killer, Victor Raines, committed the murders on instructions from Stone. The prosecution has the prison visitor's logbook that reflects Raines' visits with Stone one day before each murder. It seeks to introduce the logbook to prove Raines had in fact visited Stone at the prison on those particular dates.

In order to introduce the logbook into evidence, the prosecution relies on the testimony of Grace McMann, the Inmate Records Coordinator at Ironside. An FBI agent interviewed McMann after the murder, and the agent's report contains the following:

Ms. McMann has been employed by the Department of Corrections for eight years. She is responsible for maintaining and storing the prisoner visitor logbook. She is familiar with the procedure for admitting visitors and has personally observed the procedure from time to time. She states that normal prison procedure is that visitors are required to show identification to the lobby officer and to sign their names and record their addresses on a sheet in the logbook. The lobby officer is required to check a visitor's identification against the entry in the book. She has no personal knowledge of whether the lobby officer checks each entry in the logbook against the identification that has been shown to him, but she can say lobby officers are required to follow the prescribed procedure. She has no personal knowledge of the entries that reflect visits by a Victor Raines.

- 1. For the prosecution, conduct a direct examination of McMann and get the logbook entries into evidence.
- 2. For the defendant, oppose the offer and cross-examine McMann.
